With reference to your online application dated 30/06/2014 on the subject cited above. I am directed to convey the sanction for **Composite Provisional Affiliation for Secondary School Examination** of the Board for a period of **three years w.e.f. 01.04.2016 to 31.03.2019.**

The above sanction is subject to fulfillment of following conditions:-

1. The affiliation Code Number allotted to your school is **1930704**. This may please be noted and quoted for any further correspondence with the Board.
2. The school will implement Continuous and Comprehensive Evaluation (CCE) as per the schemes of the Board upto Classes X vide **Circular No. 39/20-09-2009 dated 20.09.2009** in the school.
3. The school will follow the syllabus on the basis of curriculum prescribed by NCERT/CBSE and text books publishing by NCERT/CBSE for the Middle Classes. The school will follow syllabus and courses as per scheme of studies prescribed by the Board for Secondary/Sr. Secondary School Examination and changes made therein from time to time.
4. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt from time to time.
5. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under :-

13. 5-6 names of persons not below the rank of Principal of Sr. Secondary School affiliated with the Board be recommended so that two of them may be approved by the Board as its nominee in the School Managing Committee. Of these 2-3 may be Principal of KV/JNV.



Provisions of Affiliation bye laws for adherence:-

1. Fees should normally be charged under the heads proscribed by the Department of Education of the State/U.T. for schools of different categories. **No capitation fee or voluntary donations** for gaining admission in the school or for any other purpose should be charged / collected in the name of the school and the school should not subject the child or his or her parents or guardians to any screening procedure i.a.w. rule no. 11.1, 2 & 3.
2. The school should not use the activities for **commercialization**:-
 - a) As per rule no. 19.1 (ii) It shall ensure that the school is run as a community service and not as a business and that commercialization does not take place in the school in any shape whatsoever.

7. 

The Board shall not be responsible for any consequences if new classes (K.V.V.V.V) are started without obtaining the prior approval of the Board and without following the Affiliation Bye-laws.
- 43. It is mandatory for every affiliated school to become a member of the local Sub-committee of CBSE schools.
- 44. In case of intentional violation of Affiliation Bye laws, directions given in the circulars and any of the above mentioned conditions to the school, the school would be liable for disaffiliation under Chapter V, Rule No. 17 of Affiliation Bye-laws.
- 45. Some of the important rules to be followed to by the school were given above for drawing specific attention of the school authorities. However, the school authorities are required to acquaint themselves with the rules contained in Affiliation, Examination Bye-laws and Circulars issued by the Board from time to time. Any lapse in following instructions of the Board will lead to action against school as per Rule 17 of Affiliation Bye-laws.
- 46. The school is required to contact the concerned Regional Office of CBSE for allocation of school number and password to online Registration of candidates.
- 47. The affiliation of the school is subject to the fulfillment of the following special conditions.  - * The school shall be solely responsible for any legal consequences arising out of the use of school name/ logo/ society/trust or any other identity related to running of school affiliated to CBSE. The school shall also be liable to bear all legal charges incurred by the Board, if any, arising out of these circumstances.
 - * The school is required to upload a commencement certificate as per appendix VIII of the existing affiliation bye laws within three months through the online link provided for the purpose, furnishing details of compliance(s) made in response to the condition(s) in the grant letter.




